#### CITATION

Technical Sergeent Curtie L. Jackson dibeinguished himself by quistanding meritorious service in the performance of duties as Maintenance Flight Chief on F-94 type aircraft assigned to the 4th Fighter Interceptor Squadron, 6351st Air Base Wing, Okinawa Ryukyu Islanda, from 1 March 1953 through 30 June 1953. During this period, the Squadron was operating from a location seventeen ailes from its source of logistic support, : yet Sergeant JACKSON consistently maintained a high aircraft in-commission rate and attained exceptionally good airoraft utilisation. He, at the same time, supervised an on-the-job training program for newly assigned personnel who possessed no previous experience on F-94 type aircraft. The manner in which Sergeant JACKSON overcase supply and maintenance difficulties, the example of resourcefulness and sense of responsibility he displayed, are in with best traditions of the service and reflect great credit upon himself, his organization, and the United States Air Force.

- 1. M/Sgt Curtis L. Jackson, . is proudly nominated as the outstanding airman in ADC, in accordance with USAF message SAFIS-5 45613, Subject: AFA Convention; ADC Letter 190-18, 29 April 1957, Subject: Outstanding ADC Airman and WAF; and letter, 9ISO, Headquarters 9th Air Division, 17 May 1957, Subject: Outstanding ADC Airman. This technically skilled airman is an outstanding individual both in his ability and performance as an Air Force supervisor and in the exemplary manner in which he conducts himself under all circumstances. His personal appearance is commanding and his character and integrity are beyond reproach. He has a far reaching background of technical experience and is presently being utilized as Flight Chief (PAFSC 43171C, additional AFSC 43270) in this F86D organization. His responsibilities in this capacity include supervision of approximately twenty-five airmen and maintenance responsibility for seven combat ready F86D aircraft. He is called upon daily to draw upon his abundant knowledge of all components and sections of the aircraft and electronics equipment. His performance during his three years service as a member of this organization has been exceptional and his record before joining this unit is exceedingly noteworthy.
- 2. M/Sgt Jackson has been associated primarily with interceptor type aircraft throughout his Air Force career. His military career, all of it devoted to the application of technical knowledge to the aircraft maintenance problem, began in June 1943, and is summarized below:

- 497 FIS, 24 May 1957, Subj: Nomination of Outstanding ADC Airman
- a. United States Marine Corps: June 1943 April 1946: Assigned as an aircraft mechanic and Crew Chief in the first Marine Corps night fighter squadron (VMF(N)533), which saw action in the battle of Okinawa (35 kills). Spent 30 days of operational training on the aircraft carrier Shangri-La (Oct 1945). Participated in photo reconnaissance modification and testing of the F6F Hellcat early in 1946.
- b. United States Marine Corps Active Reserve:
  April 1946 January 1948: After honorable discharge from active duty with the Marines in April 1946, worked for the Shell Oil Company, Long Beach, California.
  - c. United States Air Force: January 1948 Present:

- (1) Served with the 318th Fighter Interceptor Squadron at Hamilton Air Force Base, California and McChord Air Force Base, Washington as Crew Chief and Flight Chief (January 1948 January 1952).
- (2) Served with the 4th Fighter Interceptor Squadron, Naha, Okinawa, as Flight Chief (January 1952 April 1954).
- (3) Served with the 497th Fighter Interceptor Squadron (formerly the 445th Fighter Interceptor Squadron) from April 1954 to the present, in primary duty of Flight Chief.
- 3. M/Sgt Jackson has served with devotion and enthusiasm in each of his military assignments. His career is marked with several highlights which, together with his continuous excellence of performance, are believed ample justification for his selection as ADC's outstanding airman. These highlights are listed below:
- a. Assignment to MIG-15 Testing Project: Perhaps the most interesting and outstanding single achievement in M/Sgt Jackson's impressive career was his assignment to the MIG-15 project at Kadena, Okinawa in November of 1953. When a North Korean pilot accepted General Mark Clark's offer of \$100,000 reward and delivered a MIG-15 to American hands,

the problem of immediate analysis and flight testing was most urgent. This aircraft was disassembled and shipped from South Korea to Okinawa. Sgt Jackson, because of his technical qualifications and management ability was assigned responsibility for supervising and directing the assembly of the MIG-15 for flight test purposes. The task was particularly difficult since no plans, technical orders or diagrams were available. Many instruments and parts required modification both for initial installation and in order to provide valuable information from flight tests. After 32 hours of round-the-clock labor, the MIG-15 was ready for flight. General Al Boyd, Major Charles Yeager and Captain Thomas Collins performed all flight test work, with Sgt Jackson assigned as Crew Chief, authorized on orders to start and taxi the MIG-15. For his excellent performance in the project Sgt Jackson received written commendations from General O. P. Weyland and Major General Pay R. Upthegrove (See Inclosure #1) and was commended verbally by General Boyd.

- b. First J-33-33 Engine to Fly 1000 Hours: In February 1954, M/Sgt Jackson's flight produced the first J-33-33 engine to reach 1000 hours flight time. (F94A aircraft, 4th Fighter Interceptor Squadron, Okinawa).
- Awarded the Commendation Ribbon: For outstanding meritorious service as maintenance Flight Chief in the 4th Fighter Interceptor Squadron, during the period 1 March 1953 through 30 June 1953, M/Sgt Jackson was awarded the Commendation Ribbon (February 1954). A copy of the Citation is attached (Inclosure #2).
- d. Flying Safety Record: M/Sgt Jackson's flight has completed thirty-eight months of operational flying in this organization without an aircraft accident. This represents approximately 5700 hours of single engine jet time (F86D). His flight has never been charged with an aircraft accident. (The squadron received three citations for flying safety from ADC during this period).

- e. Rocketry Championship Aircraft: In 1955, when the 445th Fighter Interceptor Squadron won the Yuma Rocketry Championship, they did so using aircraft from M/Sgt Jackson's flight exclusively. One of these aircraft set a record for most hits for a single F86D aircraft, a record which still stands.
- f. First 786D to Fly 1000 Hours: M/Sgt Jackson's flight produced the first 786D to Fly a total of 1000 hours (March 1957). The aircraft, 786D 752-3646, was assigned to Sgt Jackson's flight exclusively while compiling this unique record.
