

## Instructor Officer Vacancies – 12 January 2021

**READ THIS FIRST:** Please note that we operate in 3-week cycles, continuously, all year long. When one cycle ends, another begins. New applications must be approved by the date indicated to be eligible for referral in the current cycle. If you do not make the application cutoff for the current cycle, you will make the next one. Vacancies remain advertised until we have 4 names referred simultaneously, or the school makes a hiring decision. We post all actual or pending vacancies as soon as we know of them.

2. Must have an approved instructor application on file at Holm Center/JRI five duty days prior to the close out date application must be completed and approved by COB 15 Jan 21 for this close out date of 22 Jan 21

Frequently Asked Questions about the Process

### HOW ARE APPLICANTS NOMINATED?

Following 22 Jan 21, AFJROTC will nominate qualified applicants to school officials for interview. School officials are the interview and hiring authority.

NOTE: We will continue to advertise the positions until the hiring authority closes the position

### APPLICANT RESPONSIBILITY

Applicants may volunteer for as many as four schools. This restriction is placed due to the amount of administrative workload involved. Please do not volunteer for a particular vacancy unless you are available and willing to travel to the school for an interview. Travel requirements for an interview are at the applicant's expense. Applicants who are nominated, but fail to contact the school or fail appear for interview show insincerity unfavorable to the Air Force. Such applicants may be withdrawn from further consideration

### HOW WILL I KNOW IF I AM NOMINATED

AFJROTC will notify nominated applicants within 5-10 working days after the suspense date above—please be patient, the process takes time. Applicants will be provided a point-of-contact at the school and are responsible for making their interview arrangements

### REMINDERS FOR INSTRUCTOR NOMINEES

Recommend you wear your service dress uniform to the interview. Remember, none of the information you send to us is sent to the school. All they know about you is your name; take your resume, summary, copies of records, etc., with you; whatever you feel you need to sell yourself. Applicants are not authorized to contact school officials without first being approved by AFJROTC. If you are not contacted by 5 Feb 21, you may assume you were not nominated for interview.

### \*NATIONAL DEFENSE CADET CORPS (NDCC) PROGRAM

NDCC program is virtually identical to JROTC except it is fully funded by schools that choose to pursue a JROTC unit without financial assistance from the Air Force. The school incurs all costs to include instructor salaries, uniforms, and daily operational expenses

### NOTES FOR CURRENT AFJROTC INSTRUCTORS

Instructors must apply for specific vacancies within the transfer application window of 1 November to 30 April. Instructors may not have their name added to additional schools after 30 April unless Holm Center/JRI has a copy of the officially tendered resignation *and* qualifying Departure Form 98 on file (see Paragraph 17.4.5). Instructors must serve two full school years with their current unit. Partial school years do not count. If an instructor will complete two full school years prior to actually moving (summer moves only) to a new unit, they will be allowed to apply for the vacancy. Instructors who apply for a transfer and accept a position must 1) immediately and officially resign their current position effective at the end of their current contracted school year within 15 calendar days of acceptance of the new position, *and* 2) provide Holm Center/JRI a qualifying Departure AFJROTC Form 98 from their current school within 15 calendar days of acceptance of the new position. Instructors may not contact school officials concerning vacancies unless specifically referred by Holm Center/JRI. **Instructors contacting school officials without referral may be considered ineligible for the position.** NOTE: Current instructors, who interview for, are offered, and decline a position may be ruled ineligible for transfer for one (1) school year

Department of Defense Dependent Schools (DoDDS Schools): Due to the high-visibility locations, proficiency training required, and increased cost of Headquarters visits in overseas locations, all applicants for AFJROTC vacancies in DoDDS are limited to experienced AFJROTC instructors (current and prior instructors only). Current instructors must meet the transfer criteria as stated in AFJROTCI 36-2010 to be considered. Prior instructors must be in good standing and have received a satisfactory AFJROTC Form 98 from their previous school when they departed. DoDDS also requires all candidates to have a completed DoDDS application on file prior to consideration, the application may be completed via the DoDDS website.

NOTE: Anyone interested in a particular vacancy should not attempt working with the school directly until HQ AFJROTC officially refers them as an approved applicant. HQ AFJROTC's goal is to provide and maintain a fair and equitable nomination process so that any interested applicant has an equal chance at a particular vacancy. If it is determined that a particular applicant is circumventing this official process in an attempt to gain an advantage, that applicant may be rendered ineligible for that vacancy. HQ AFJROTC Instructor Management reserves the right to make that determination.
